

Mexico City, Mexico, April 03, 2020. Unifin Financiera, S.A.B. de C.V. (ticker: UNIFINA) (“Unifin” or the “Company”), informs that, in relation to the unusual movements presented today in the operation of the Company, the issuer reports that it has no knowledge of the causes that could have originated said movements.

This clarification is requested by the Mexican Stock Exchange, based on the provisions of the Article 106 of the Securities Market Law, and the Article 50, penultimate paragraph, of the General Provisions applicable to securities issuers and other stock market participants.
